Thank you for your message.

Please note that this communication is deemed to be ex parte communication under the Regulatory Authority Act 2011 ("RAA"), as it is the subject of an ongoing public consultation. Section 73 of the RAA restricts how the Regulatory Authority (the "Authority") can treat ex parte communications. In particular, it requires the Authority to publish all ex parte communications on its website.

With reference to your email, the methodology is purely focused on the export of electricity to the grid and is independent of any renewable energy system size. The consultation is only on the methodology, and does not set a rate. However, the methodology stated will be used to determine a rate at future rate reviews. As such, it is not possible to provide an example.
